**The jobs program includes a nine-week course of 12 classes. The classes are free and open to anyone needing help gaining employment. They are held at the old Bloomington Junior High School at 510 E. Washing-ton Street, Bloomington, and run from 6:00 to 8:00 p.m. Once a person has attended all the classes, he or she can attend a job fair where potential employers gather to hire employees.**

*\*\*There is also a support group which meets Wednesday evenings from 6-8pm. Participants in the program receive weekly job leads, mentors, and can receive assistance with employment, housing, transportation, food, and clothing. \*\**
