## **Safelink Phone:**

### **Provides eligible consumers with a cell phone.**

The Safelink/Lifeline program is available to eligible consumers in selected states and territories. Actual requirements vary by state, but in general to qualify for Lifeline, subscribers must either have an income that is at or below 135% of the federal Poverty Guidelines or participate in one of the following assistance programs: Medicaid, Supplemental Nutrition Assistance Program (SNAP) Food Stamps, Supplemental Security Income (SSI), Federal Public Housing Assistance (Section 8), Veterans and Survivors Pension Benefit.

TIPS: An interview (either in person or via phone) is required for SNAP (food stamps) and cash assistance. You may only qualify for Cash assistance if you have a related dependent under the age of 18 in your custody full time, receive SSI benefits, or are over the age 65 and meet income requirements. If you qualify for expedited snap benefits and opt to pick up your link card at your local DHS office, you will need a photo ID.
