TIPS: An interview (either in person or via phone) is required for SNAP (food stamps) and cash assistance. You may only qualify for Cash assistance if you have a related dependent under the age of 18 in your custody full time, receive SSI benefits, or are over the age 65 and meet income requirements. You may be eligible for a free phone from the government if you are a participant of any of the following government-paid programs: Medicaid; Food stamps/Supplemental Nutrition Assistance Program (SNAP); Supplemental Security Income (SSI); Veterans Pension and Survivor's Benefits; Section 8/Federal Public Housing Assistance; Tribal Temporary Assistance for Needy Families (TANF); Bureau of Indiana Affairs General Assistance (BIA); Tribal Head Start (only those households meeting its income qualifying standard); Food Distribution Program on Indian Reservations (FDPIR).
