The Board also discussed trainings for 2015 and agreed that juvenile specific trainings should be the focus. A series of three to reach the northern, central, and southern parts of the state was also proposed. Potential topics include juvenile development, treatment, supervision strategies, pertinent law, transfer to criminal court from juvenile court, as well as the petitioning process for removal from the registry were proposed. Jackie will be reaching out to the Juvenile Justice Commission to discuss possible presenters.
