Subject: Latest COVID-19 Information

COVID-19 remains a serious concern across the country and here in Illinois. The Illinois Department of Public Health (IDPH) is reporting 24 counties in Illinois that are considered to be at a warning level for COVID-19. A county enters a warning level when two or more COVID-19 risk indicators that measure the amount of COVID-19 increase, like test positivity rate and hospital admissions. These counties are Bond, Bureau, Cass, Clinton, Coles, Crawford, Cumberland, DeWitt, Edwards, Effingham, Greene, Jasper, Jo Daviess, Lawrence, Madison, Marion, Rock Island, St. Clair, Shelby, Washington, Wayne, Williamson, Wabash, and Union.

At the Illinois Department of Corrections, our response to the virus continues to be deliberate and aggressive. For nearly 200 days, we have instituted measures to mitigate COVID-19 spread within our facilities, including but not limited to:

- Restricting movement within facilities;
- Isolating and testing anyone who is symptomatic;
- Quarantining exposed asymptomatic men and women in custody;
- Managing chemical and medical supply inventories;
- Implementing deep cleaning routines;
- Equipping everyone with masks;
- Conducting temperature checks;
- Monitoring everyone for symptoms.
