**Sec. 5-8-1.1. Impact program**

(j) The Department shall report to the Governor and the General Assembly on or before September 30th of each year on the impact program, including the composition of the program by the offenders, by county of commitment, sentence, age, offense and race.

The current Impact Program (IP) facilities are located at Dixon Springs (temporarily vacant) in the Shawnee National Forest in southeastern Illinois, at the DuQuoin State Fairgrounds in southern Illinois (currently housed at Murphysboro), and Logan Correctional Center.

In FY2025, 67 individuals exited the Impact Program. The individuals were recommended for admission to the IP by Judges in 30 different counties. Of those admitted into IP, 68.7% (46) successfully completed the program and were released to Mandatory Supervised Release (MSR) in the community.

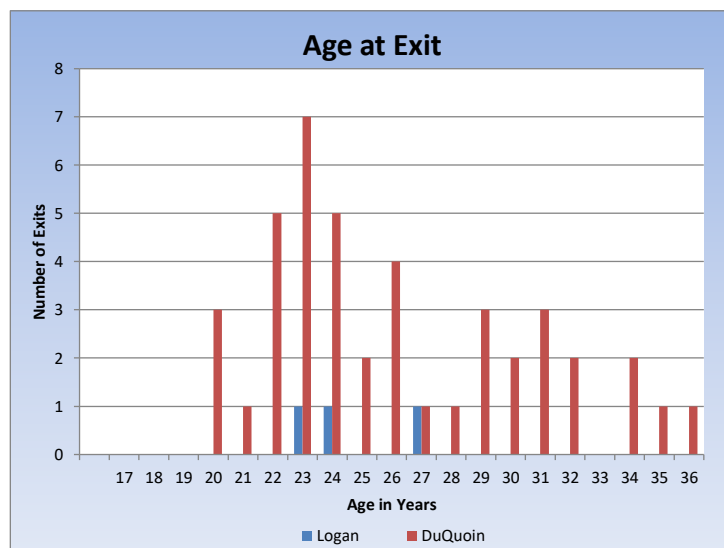
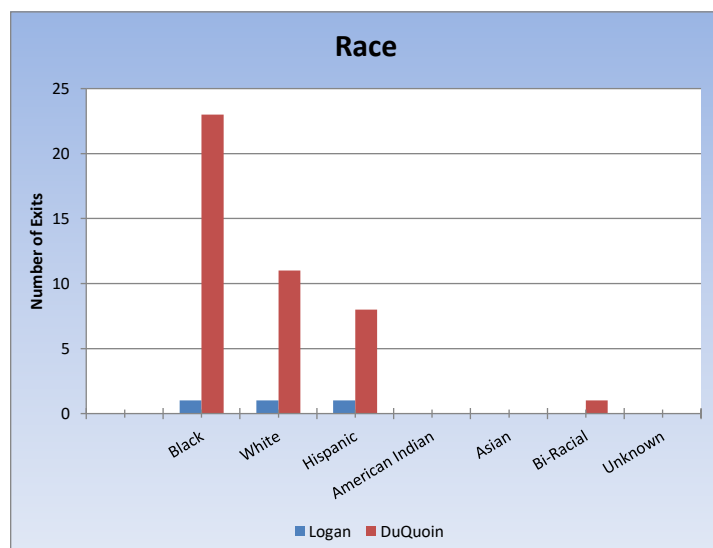
