In accordance with the Unified Code of Corrections, Director S.A. Godinez respectfully submits the following data regarding the award of sentence credit for good conduct, or also known as "Supplemental Sentence Credit" to the General Assembly. This sentence credit of up to 180 days is awarded at the discretion of the Department to eligible offenders pursuant to Section 3-6-3(a)(3) of the Code of Corrections. During the past year the Department finalized rule-making with the Joint Committee on Administrative Rules that permitted the award of the sentence credits to begin in March 2013. We anticipate the data for the next full reporting year (October 1, 2013 to September 30, 2014) will be greater.

- (3.5) The Department shall provide annual written reports to the Governor and the General Assembly on the award of sentence credit for good conduct, with the first report due January 1, 2014. The Department must publish both reports on its website within 48 hours of transmitting the reports to the Governor and the General Assembly. The reports must include:
 - (A) the number of inmates awarded sentence credit for good conduct;
 - (B) the average amount of sentence credit for good conduct awarded;
 - (C) the holding offenses of inmates awarded sentence credit for good conduct; and
 - (D) the number of sentence credit for good conduct revocations.
