In accordance with the Unified Code of Corrections, Director S.A. Godinez respectfully submits the following data regarding the award of sentence credit for good conduct, or also known as "Supplemental Sentence Credit" to the General Assembly. This sentence credit of up to 180 days is awarded at the discretion of the Department to eligible offenders pursuant to Section 3-6-3(a)(3) of the Code of Corrections.

For the time period represented in this report; October 1, 2013 through September 30, 2014; there were 2,216 inmates that exited with an average of 133.5 days supplemental sentence credits. These figures are slightly higher than those reported last year. Further, 390 cases had supplemental sentence credits revoked with an average of 35.0 days.

The figures in this report reflect the July 2016 revised data. The data program was capturing some pending cases that were denied, and were not awared. This resulted in 235 less cases exiting with supplemental sentence credits, and 61 less revoked cases.

 - (A) the number of inmates awarded sentence credit for good conduct;
 - (B) the average amount of sentence credit for $good\ conduct\ awarded;$
 - (C) the holding offenses of inmates awarded sentence credit for good conduct; and
 - (D) the number of sentence credit for good conduct revocations.
