In accordance with the Unified Code of Corrections, John Baldwin respectfully submits the following data regarding the award of sentence credit for good conduct, or also known as "Supplemental Sentence Credit" to the General Assembly. This sentence credit of up to 180 days is awarded at the discretion of the Department to eligible offenders pursuant to Section 3-6-3(a)(3) of the Code of Corrections.

For the time period represented in this report; October 1, 2016 through September 30, 2017; there were 1,173 inmates that exited with an average of 85.5 days supplemental sentence credits. Further, 192 cases had supplemental sentence credits revoked with an average of 27.7 days. These figures have decreased from the 2016 report, along with the prison population during the same reporting period.

Sec. 3-6-3. Rules and Regulations for Sentence Credit.

(3.5) The Department shall provide annual written reports to the Governor and the General Assembly on the award of sentence credit for good conduct, with the first report due January 1, 2014. The Department must publish both reports on its website within 48 hours of transmitting the reports to the Governor and the General Assembly. The reports must include:

- (A) the number of inmates awarded sentence credit for good conduct;
- (B) the average amount of sentence credit for good conduct awarded;
- (C) the holding offenses of inmates awarded sentence credit for good conduct; and
- (D) the number of sentence credit for good conduct revocations.
