In accordance with the Unified Code of Corrections, the Illinois Department of Corrections respectfully submits the following data regarding the peer-led Civics course administered at all correctional facilities.

The following figures are a representation of participants and completers per Public Act 101-0441 effective January 1, 2020. All individuals exiting an IDOC facility are offered the Civics handbook containing course information prior to their release. It should be noted that individuals have the right to decline taking the course and/or receiving the handbook.

For the time period represented in this report; January 1, 2025 through December 31, 2025; there were 14,174 individuals that exited IDOC. Of those exits, 10,107 individuals were given the Civics handbook prior to their release. In CY25, 6,471 individuals were enrolled in the Civics course and 5,579 individuals had completed the course.

- (C) the total numbers of individuals discharged segregated by institution.

Note: On January 1, 2020 per Public Act 101-0441 the Department was required to report variables that had not historically been collected. The implementation and collection of this data is evolving and numbers reported are subject to change as future programming becomes available.

Note: Work camps, Joliet In-Patient Treatment Center, Graham R&C, Stateville Farm, Menard R&C, and Menard Medium Security are recorded under their parent facilities. DuQuoin Impact Program is recorded under Murphysboro Life Skills Reentry Center.

¹ All individuals exiting IDOC are offered the civics handbook. The Department acknowledges the distribution of civics handbooks is much higher than what is reflected in the official numbers. This is a result of the manual effort required to input data into the tracking system of record. Training of staff for data entry of the civics variables in the tracking system of record is ongoing. Numbers of handbooks received and course enrollees/completers will increase and be more reflective of our efforts in future reports.

² Discharge refers to any individual who was released from an IDOC facility and is no longer under state supervision.

³ MSR refers to any individual who was released from an IDOC facility who is under parole supervision.

⁴ Exit refers to all individuals who were released from an IDOC facility including those that are under supervision and those who are discharged.
