- an MSR or parole rule violation.
- 7 Other is defined as an adult who is admitted to IDOC from another custody or who has been returned to custody without having been sentenced.
- 8 Sex offender registrants are defined as individuals required to register as a sex offender
- for having a sex offense or a murderer/violence against youth offense on the sentencing order; excluding prostitution.

End of Propulation is the population of the task day of the Piscal real, volte South * In December 2015 IDOC initiated a majori IT transition, moving from a DOS-based offender tracking system to a modern, web-based tracking system. During the transition, some traditional measures will contain missing values due to a combination of factors, which include quality control issues with data entry and missing data for fields that are no longer required within the system. In addition, basic coding and program logic is still being reviewed and corrected.
