² Sentencing County: County where the crime occurred and the inmate was committed. Collar Counties (5): DuPage, Kane, Lake, McHenry and Will. Downstate Counties (96): Illinois counties other than Cook County and collar counties.

³ Admissions to IDOC during each fiscal year (July 1 - June 30). FY19 Admission History has been updated/corrected and will differ from the older versions of the FY19 Admission History on previous versions of Fact Sheets.

⁴ Court admission is defined as an adult admitted from criminal court who was not on MSR/Parole when the crime occurred.

⁵ A new offense violation is defined as an adult who was on MSR/Parole and has been convicted of a new offense that is different from their current holding offense.

⁶ A technical violation is defined as an adult on MSR/parole readmitted because of an MSR/parole rule violation or readmitted with new charges pending.

⁷ Other is defined as an adult admitted to IDOC custody for something other than an MSR/Parole violation, including admission from other custody or violation of some other form of release.

⁸ Sex offender registrants are defined as inmates required to register as a sex offender for having a sex offense or a murderer/violence against youth offense on the sentencing order; excluding prostitution.

⁹ Prison turnarounds are offenders that were in IDOC reception 48 hours or less before being released to MSR, parole, or other custody.

¹⁰ Jail turnarounds are offenders that are held in a county facility in lieu of coming to IDOC Reception. IDOC received the offender paperwork 48 hours or less before being released.

* End of FY population is the population on the last day of the Fiscal Year, June 30th.
